



# 4,250+

#### students reached

in our school-based programs, services and presentations held throughout the year.

- 2,885 students in grades K-12 reached with programming across 14 Mercer County schools
- 840+ students reached through Life Skills Training
- 1,891 reached through ASYSST programs and events with 154 unique students receiving supportive services
- 1,377 students reached in presentations and assemblies held by our Prevention Education staff



# 1,750+

in our community-based programs and initiatives held throughout the year.

- 386 attendees across 52 weekly All-Recovery Meetings
- 162 individuals connected to support through the Opioid Overdose Recovery Program, with 131 non-hospital cases
- Over **200** reached through Older Adults presentations
- 109 substance use evaluations and referrals in collaboration with the Juvenile Justice Commission
- 320 total attendance across monthly meetings with our Prevention Coalition of Mercer County
